• The design team continue to liaise with the Acoustician and Fire Consultant as required.

- Design works are coming to a close and ongoing meetings between the client and contractor teams is ensuring all technical aspects of the construction are concluded.
- Apartment specifications are being finalised alongside RW Invest to ensure all finishes and equipment are correct and up to the standards required.
